

Severe Weather and Tornadoes (KY, MO, VA)

SitRep – May 23, 2025

Good360 Disaster Response Activation Status – **Full Activation**

Situation Overview

It has been seven days since severe weather and tornadic activity devastated communities in Kentucky, Missouri, and Virginia, and immediate response operations are underway. While damage assessments are still ongoing, the American Red Cross estimates that 226 residential structures in Kentucky and 42 in Missouri were destroyed, rendering these homes uninhabitable. In addition, more than 352 homes sustained major or significant structural damage while at least 1,151 incurred minor to slight damage. Overall, the storm outbreak produced approximately 50 tornadoes and may have resulted in more than \$1B in damage across affected states.

Ongoing Concerns

Hazardous weather conditions are expected in portions of Western Kentucky and Southeast Missouri today into this evening and may produce heavy flooding. Rainfall amounts may average 1 to 3 inches in some areas with potential higher totals in Southeast Missouri. This could delay cleanup efforts in tornado-affected regions and/or exacerbate overall storm impacts.

Good360's Response

As our Disaster Response and Recovery team continues to manage assistance requests, approximately \$250,000 worth of critically needed products have been deployed to support response efforts in Kentucky and Missouri, impacting over 1,000 lives. We have also distributed \$7,000 worth in Lowes gift cards. In addition, Peyton Kliever (Director of Program Development) joined our partner Every Shelter in London, KY yesterday to provide high-quality Roof Patch Kits for tornado-affected communities in London and Somerset. The team delivered five boxes with a total of 250 kits to these communities.

Coordination Calls and Agency Updates

Kentucky Voluntary Organizations Active in Disaster (VOAD)

- Most damage assessments are complete.
- Hardest hit Kentucky counties include Laurel and Pulaski, which account for 177 of 226 residential structures that were destroyed in the state.
- Feeding ops are shutting down, groups moving into supply distribution.

May 19, 2025

Situation Overview

On May 16, severe weather and tornadic activity devastated communities in Kentucky, Missouri, and Virginia, resulting in significant displacements and lasting impacts on many lives. At least 28 fatalities (Kentucky 19, Missouri 7, and Virginia 2) and more than 100 injuries have been reported as search and rescue operations are underway. Though damage assessments are pending, more than 1,300 structures in Kentucky and 5,000 in Missouri are believed to have been affected. In response to the storms, Kentucky Governor Andy Beshear and Missouri Governor Mike Kehoe declared a State of Emergency. In addition, several local State of Emergency declarations were issued including Pulaski County in Kentucky. As residents impacted by this incident begin the arduous process of cleanup and recovery, they are bracing for yet another incoming storm system that may lead to further destruction.



Ongoing Concerns

- A boil water advisory is currently in effect for about 9,500 individuals in Kentucky.
- Incoming storm system Monday – Tuesday (5/19 – 5/20) that may cause additional tornadic, wind, and water damage.



Good360's Response

In recent months, Good360 has been assisting the State of Kentucky as communities recover from multiple incidents, three of which led to disaster declarations. Thus far, we have supported non-profit partners by deploying approximately 336 pallets or \$781.5K worth of products, impacting approximately 23,193 lives. Additionally, we have aided the State of Missouri during two disaster events this year with \$247.1K worth of goods. As we continue our response efforts, we will work closely with our non-profit partners to identify gaps in unmet product needs and extend our support to provide relief to affected communities across impacted regions.
